Section 138:- Internal auditor

The following class of companies shall be required to appoint an internal auditor:

- Every listed company
- Every unlisted public company having
 - Paid up share capital of 50 crore rupees or more during the preceding financial year; or
 - Turnover of 200 crore rupees or more during the preceding financial year; or
- Outstanding loans or borrowings from banks or public financial institutions exceeding 100 crore rupees or more at any point of time during the preceding financial year; or
- Outstanding deposits of 25 crore rupees or more at any point of time during the preceding financial year; and
- Every private company having
 - Turnover of 200 crore rupees or more during the preceding financial year; or
 - Outstanding loans or borrowings from banks or public financial institutions exceeding one hundred crore rupees or more at any point of time during the preceding financial year.

Section 139:- Appointment of auditor

Appointment of First Auditor

- The first auditor of a company, other than a Govt. Company, shall be appointed by the board of directors within thirty days from the date of registration of the company.

Appointment of Subsequent auditor

- In the case of failure of the Board to appoint such auditor, it shall inform the members of the company, who shall within ninety days at an extraordinary general meeting appoint such auditor and such auditor shall hold office till the conclusion of the first annual general meeting.

Tenure of appointment

- An individual as auditor shall not be appointed for more than one term of five consecutive years; and
- An audit firm as auditor shall not be appointed for more than two terms of five consecutive years.

Appointment of auditor in Government company

- In the case of a Government company or any other company owned or controlled, directly or
